TERMS OF LEASE:

_____ No Equipment will be reserved for anyone until this contract is completed & funds are received.

_____ Any trailers leased for less than a 3 month period are subject to sale without notice to lessor.

_____ All Leases will require a deposit based on mileage from Lessors to Lessee location, which will be refunded within 1 month after the equipment is returned at the end of the lease term and our shop has reported equipment as being in the same condition as when lease began (ordinary wear and tear is excepted). **The deposit can not be applied to rent.**

_____ All Leases will require AT LEAST one advance rent payment. **Lessee will remain at least one payment in advance**, with payments on weekly rentals due one week in advance and payments on monthly rentals due one month in advance. **If Lessee fails to pay rent in advance, Lessor will pick up the equipment at Lessee's expense and forfeit their deposit.** There will be no exceptions. If you feel you may be too busy to send check during use, pay in full now.

_____ Equipment shall be clean when returned or a **\$65.00 fee** will be deducted from deposit.

_____ If Lessee returns equipment before the end of the agreed lease terms and has not paid Lessor in full. **Lessee will forfeit deposit and remain responsible for all rent due throughout the remainder of the lease term, which shall become immediately due and payable.**

_____ Lessee will be responsible for any damages not noted in advance of the lease.

_____ Lessee will be responsible for excessive rock chips on undercoating; lessee should always have mud flaps on truck.

_____ Lessee shall have all repairs made at a shop approved by the Lessor and manufacturing company, so that any and all remaining warranties remain in effect.

_____ Lessee will carry FULL COVERAGE insurance that states Chuck Henry Sales, Inc. as the loss payee. Proof of insurance with unit serial number will be provided to Chuck Henry Sales, Inc and remain in effect until equipment is returned and a release is signed by Chuck Henry Sales, Inc. Any damages to product hauled/stored in leased equipment will not be Chuck Henry Sales Inc. responsibility.

_____ Lessee is responsible for return of equipment in the same condition as described in this contract, ordinary wear and tear excepted, to Chuck Henry Sales, Inc., 525 N. Poplar, Solomon KS 67480, during regular business hours. Any and all cost incurred by Chuck Henry Sales, Inc. to recover said equipment will be charged to the lessee.

_____ Lessor may terminate this agreement at any time, and Lessee shall be responsible for return of the equipment to Lessor upon termination.
